4. Recurring Business:

- **4.1 Staff Shortages:** No report available, in the past month some family members have noted some staff shortages on various floors but no specific numbers available
- **4.2 Resident Hand Hygiene:** Difficult to assess if recommendations are being followed, as there have been limited activities due to recent month long outbreak.
- **4. Cassellholme Website:** work continues on the website
- **4.4 Humanizing Discharge (renamed) Procedure**: No update as meeting was postponed
- **4.5 Political Action Working Group**: Brief review of presentation that Ann and Blanche-Helene made to various politicians in Sudbury, were interviewed by CBC radio
- **4.6 Long Term Care Act Amendments:** Notice received from CUPE rep of a rally in Toronto on Feb. 27/18 to show support for Bill 33 (Time to Care Bill). The Bill has passed First and Second readings and now

goes to a Standing Committee. Various other groups are showing support for this Bill to ensure that it progresses through the system before the Provincial Election occurs.

- Check the UNIFOR website for a video titled "The Six Minute Challenge", addresses the challenges of caring for individuals within such limited time constraints.
- the Ontario Health Coalition notes some concerns regarding the four hours of care recommended, it may not just include nursing/PSW care but may also include physio and other health care specialities
- the Ontario Health Coalition may develop some specific questions on postcards regarding areas of concern in Long Term Care Homes (referendum format), these could then be used when raising issues with the government
