Family Council Education

Mandy Gilchrist provided an overview of the activity programming at Cassellholme.

- Every two years the activity staff changes units. Mandy showed pictures of the current staff on each unit. It was suggested that staff names and pictures be posted on each unit near the activity white board.
- Each resident is encouraged to participate in 385 minutes of activity every week. This is tracked monthly and if this goal is not being met staff and volunteers are instructed to focus on 1-1 visits. 1-1 visits include things such as pet visits, walks, music and tech time so residents use an iPad to send emails or set up video chats.
- Starting this month, new activities are being introduced including:
 - Morning greeting
 - Bread making - using donated bread machines
 - Lunch with Jen – preparation of a special meal
 - Scrapbooking - to help organize residents' photos
 - Photo booth – to document residents' life at Cassellholme for families
 - Book Club
 - Stamp Club
 - Beat the Clock – games
 - Sports Corner

Staff members are being encouraged to take all activities to the next level. For example – setting the table for tea with table cloths and flowers.

- On Cherry Lane, parallel activities are programmed to help meet the needs of residents with behavioral issues.
- During the recent outbreak, the staff took part in training. Some staff will take part in upcoming Montessori training for seniors in Powassan.

- The activity program is always evolving as the make-up of the residents changes. Things such as baking are always popular. There are 2 shopping trips per month and once the weather warms up there will be trips to the waterfront and the usual garden parties and BBQ's. Any suggestions for new activities are always welcome.
- Currently, one of the big challenges is to find things to engage the 10 or so residents that are under 60 years old. Another challenge is that most of the staff are part-time and most are in their 20's and 30's.

Minutes of Previous Meeting	Motion 006/20 Karen Gooch/ Nancy Tod moved that the minutes from the February 4 th , 2020 meeting be approved as presented. Carried
Evaluation	There were no issues identified in the self-evaluation forms from the February meeting.
Family Council Brochure	Appendix I Jillian Duchesne and Nancy Tod have been working on a Family Council Brochure which will be available at the front of the building and included in the welcome package. This brochure was prepared by is aimed at family, friends and caregivers of Cassellholme residents. A draft of the brochure (Appendix I) was presented and generally, it was well received by the members present. There were several comments made: <ul style="list-style-type: none">▪ Is it possible to get a testimonial in French?▪ There was a question about whether the list of extra projects might discourage recruitment if potential members felt the need for ongoing volunteering beyond our regular meetings. The list is intended to highlight the fact that Family Council can have an impact on life at Cassellholme.▪ There was positive feedback about the appearance. Jillian will email a PDF copy to everyone and invited asked that further feedback be received by March 5 th . She will also circulate a draft copy of the booklet they are working on about grieving and dying that she is working on.
Board of Management	The Board of Management will meet on March 5 th , 2020 at 5:00 p.m. All are welcome to attend.
Discussion/Sharing	A time of discussion was held for members to share any personal concerns or comments they may have: <ul style="list-style-type: none">▪ We discussed several Inspection reports that were circulated to the members by emails. There were questions about whether one incident was abuse or simply rudeness. Blanche-Hélène Tremblay will review the definition of abuse in the LTC manual.▪ There are rumours that there are unreported cases of Covid-19 at Cassellholme. There are none at this point and we were assured that Cassellholme is fully equipped with a plan and protection equipment to handle an outbreak. Everyone on staff has been measured for an N95 mask. Émilie Johnson is registering for a webinar about Covid-19.
Research and Advocacy	Appendix II Émilie Johnson will be leading the research and advocacy work group. She has met with Ann McIntyre and Blanche-Hélène Tremblay to gain a better understanding of her role. The goal of this group is to influence decisions that affect residents of long-term care both at Cassellholme and throughout the province. Blanche-Hélène presented a draft of the role of this group (Appendix II). Each member of Family

Council is invited to choose a website or other source of information, check it regularly then report back to the council so that members are up-to-date.

As a member, you'll get up-to-date information from Cassellholme about both successes and issues faced in delivering compassionate care to residents.
