Cassellholme Family Council Meeting

Territorial Acknowledgement Monique Peters offered an acknowledgement that we meet on First Nations territory. We are reminded that we should offer care and gratitude for the land and honour the indigenous teachings of those who have been here before us.

Guest Speaker

Trisha Normand was supposed to speak with us about wound care at Cassellholme. Unfortunately, she was not able to attend. Jillian Marchand agreed to find someone to attend an upcoming meeting to talk about this subject and then offered a very brief overview.

- There is a wound care committee as required by the Long-term Care Act. It is chaired by an RN and has a mandate to ensure provincial standards are adhered to.
- If you have questions about wound care, pass them on to Jillian so they can be addressed at an upcoming meeting.

Cassellholme Update

Monique Peters welcomed Jillian Marchand, Family Council Assistant. She offered the following Cassellholme update.

- <u>COVID</u> There indications that the number of cases of COVID-19 is rising in the community. The Ministry of Health is not providing a lot of information, but deaths, hospitalizations and outbreaks are all going up. There is a push for the government to provide more information about outbreaks. There have been some Cassellholme staff members who have tested positive recently, but to date these cases cannot be linked to the facility so an outbreak has not been declared. Cassellholme continues to monitor the situation while working with the Health Unit. All residents are screened daily and will be isolated until a PCR test can be done if symptomatic. There is no shortage of PPE at Cassellholme. Not all Long-term care facilities have an infection manager, but this will soon be mandatory. Ellen Whittaker has been doing this job at Cassellholme for many years and she is highly trained. The guidance document from the government has not been updated since June and a number of COVID restrictions remain in place.
- Redevelopment The new entrance has opened and there have been a few issues. The new signage was not ready for the opening and there have been problems with parking. It has been a challenge to keep staff from parking near the new entrance and this is compounded by the fact that the new staff lot at the back is not ready yet. The drop-off area is not adequate and solutions are being sought that will not reduce the number of regular spots. Currently, there

are only two marked handicapped spots and their use is being monitored to see if more are needed. The canopy at the front of the building has come down and preparations have begun for the new building. The piling should begin mid-August (slightly behind schedule) and be ongoing for 5-6 weeks. If there are concerns or questions regarding the project, contact Jillian and she will pass items on the Dave Smits. Dave is willing to meet to address anything of concern, if required. There was a question about the fact that the balconies are closed to the residents. This is part of the effort to reduce the dust levels in the building during construction.

- Staffing There have been concerns expressed about the staffing levels. Scheduling is governed by collective agreements and levels of frontline staff should be the same seven days a week. If there is an issue getting help from the staff, this should be brought up to the Unit Manager. There are cameras that can be used to monitor staff activity if needed. Staff members are being encouraged to make better use of voicemail by keeping the messaging up-to-date, including who is covering if they are not available.
- Jillian thanked people for being patient as there has been a lot of change. She reminded us that some changes have happened because of our feedback and that even positive changes can be challenging at times. Jillian also pointed out that there has been a high level of resident turnover in recent weeks which also can add to stress levels.

Monique Peters thanked Jillian for her report and added that it appears as if Cassellholme is generally doing a good job of trying to keep on top of things.
