Cassellholme Family Council Meeting

Territorial Acknowledgement Monique Peters acknowledged that we meet on the territory of the Nipissing First Nation and that we are grateful for the lessons from our Indigenous neighbours about caring for creation. She also reminded us that December 5th has been designated as International Volunteer Day.

Cassellholme Update

Jillian Marchand offered the following Cassellholme update

- <u>Doctors</u> Dr. Prins is leaving Cassellholme after 17 years of service and we are grateful to him for his work over that time. Going forward, each resident will be assigned to one of the physicians from Cassellholme's new medical team of 4 doctors plus the recently hired Nurse Practitioner. The Medical Director will be Dr. Renée Gauthier. She will oversee the activities of the whole medical team and will take care of some of the residents on Maple Street as part of her duties. The rest of the residents will be assigned to Dr. Bailey Steele, Dr. Danielle Nelson and Dr. Kara-Anne Green-Ward. All of the doctors currently have admitting privileges at the North Bay Regional Health Center and are actively practicing medicine in the wider community. Erin Brophy, NP will be working full time at Cassellholme and will working closely with all the doctors. In the coming weeks, family members will be contacted by the doctor that has been assigned to their resident. There will be a learning curve as this new system is implemented, but it is expected that the doctors will be available to families for consultation when required. So far things seem to be working well and there is a lot of excitement about this new model of care. Biographies of all the Medical Team can be found on the Cassellholme website. - Room Mock-up A mock-up of a private room in the new building is now in place in the auditorium. Jillian suggested that the next Family Council meeting could be held in-person to tour the room and have a discussion about it. There will be time to discuss this option later in this meeting. Everyone is invited to drop in to view the mock-up in the coming weeks. Feedback about things such as layout of the furniture, the number of outlets and placement of lighting would be greatly appreciated and can be given to Jillian at any time.
- <u>COVID Outbreak</u> The most recent COVID outbreak has been declared over. There were 22 confirmed cases among residents and 44 staff members were infected. Cassellholme did well compared to other local facilities that have

had recent outbreaks, some of which had 45% of their residents become infected. But here is always room for improvement. Cassellholme is one of the few facilities that is still testing staff.

- <u>Christmas</u>– The Activities Staff have organized unit-based Christmas parties this year on December 16th and 17th for the first time since the start of the pandemic. Times will be posted for each unit. The Giving Tree is located in the main lobby with tags for gift suggestions for residents. People are asked to bring unwrapped gifts to Jillian by Monday December 11th. This is a way to ensure that all residents receive a present for Christmas. People can also make a monetary donation towards this project.
- <u>Staff</u> There is an orientation session for staff every 2 weeks. Unfortunately, a high percentage of new hires do not stay long term.
- Quality Improvement The annual satisfaction survey has been emailed out (one per resident) either to residents or POAs. Accommodations have been made for those not using email. The deadline has been extended to December 11th and volunteers are available to help residents that are capable of doing the survey. Dr. Gauthier has agreed to be part of the Quality improvement team. QI will be focusing on reducing the number of ER visits, the use of antipsychotic drugs and antiracism education.
- Construction The construction team is closer to firming up a move in date for later in 2024. Moving plans are also being firmed up and Cassellholme has been in touch with the Ministry of health which has guidelines for moving residents that must be met. Attention is also being paid to staff concerns around the move.
- <u>Inspections</u> There are improvements being made to how inspections of Long-term Care facilities are carried out and Family Council will have a role to play. Other facilities in Northern Ontario have been inspected recently so and an inspection should happen at Cassellholme soon.

Monique Peters thanked Jillian for her report and reminded people that any concerns or question should be brought forward to her or Jillian before the next meeting to allow Jillian a chance to review them beforehand.
