Territorial Acknowledgement Monique Peters acknowledged with gratitude that we meet on the territory of the Nipissing First Nation and that we honour the teachings of our Indigenous neighbours and thank them for their care of the land.

Cassellholme Update

Tracy Davis, Resident and Family Navigator offered the following update about what is happening at Cassellholme. It has been busy the past few weeks. During the recent outbreak, a number of staff members also became sick which has added to the workload.

- <u>Staffing</u> The following staffing changes have been made:
 - Lindsay Dyrda will be leaving as Director of Care and Cassellholme is currently seeking someone internally to fill the role on an interim basis.
 - Bev Von Hassel will now be the manager of Clinical Operations
 - Kellie Ross will provide guidance and oversight for the Registered Practical Nurses and Teams Leads as a Clinical Practice Coach.
 - Kathy MacDonald will conduct audits, implement quality improvement initiatives and ensue adherence to long-term care regulations as Manager of Clinical Assurance.
 - Alysia Loyer will take over the role of Resident and Family Navigator.
 - Ellen Whittaker, Manager of Infection Prevention and Control will along with Camille Bigras cover the role of Director of Care until someone is appointed on an interim basis.
 - Tracy Davis will continue her spiritual support work for staff and residents and she will also be coordinator of volunteer service. Her support role for staff has become very important. She will remain the Staff Support for Family Council.
 - Derek Callaghan will take on the role of Operations Support Coordinator providing operational and program support across all services.
- Redevelopment The move-in date will now likely be late July or August due to construction delays.
- <u>Survey</u> Tracy will check to see if the results are available for distribution.
- <u>Visitor Policy</u> Family Council has asked that Tracy clarify the Visitor Policy since there are several versions of the policy floating around. Also, there was a request to have someone speak to Family Council about Cassellholme's use of the Trespass Act when there is an issue with visitors

- since there are currently several news stories about problematic use of this Act.
- <u>Alzheimer's Society</u> The has been an information session with someone from the local Alzheimer's Society. It has been fully booked and the hope is to plan more sessions.
- <u>Bracelets</u> The resident ID bracelets have been very helpful for new staff members. The are still a few glitches to work out including some bracelets falling off.

RNAO Clinical Pathways

Nurse Manager Kathy MacDonald spoke about the Registered Nurses' Association of Ontario (RNAO) Clinical Pathways program that is being implemented at Cassellholme. The planned implementation date is March 27th, 2025.

- There are currently 100 facilities using the Clinical Pathways program and among other things it will provide evidence-based tools that can be helpful when comparing outcomes with other long-term care facilities.
- There is work being done to ensure that the parameters of the program fit with the Long-term Care Act. Measurable outcomes will help to enhance care and efficiency which will improve health outcomes while reducing complications.
- The program promotes collaborative staff teamwork and resident-centered
 care, streamlining how residents care works. There are pre-built assessment
 tools that provide prompts and improved note-taking capabilities which
 saves time. There are nudges to ensure that a resident's care plan is being
 properly implemented.
- There will be a learning curve but this program is embedded as a part of the Point Click Care software already in use. Coaching is available from the RNAO.
- Often the terms of the Long-term Care Act are interpreted differently at different facilities which leads to different processes. Clinical Pathways will help unify processes across the province.
- Work on this program has been going on for many years and has provided quality data to assess care, resulting in a reduction of errors. This will also help when training new staff coming from other facilities using Clinical Pathways. As a new staff member, Kathy stated that in her experience Cassellholme is already doing a good job with resident care.
